

# EXHIBITION CONDITIONS INTERNATIONAL FESTHALLEN HORSE SHOW 2023

## 1. General

1.1. Rental contract: The exhibition conditions listed below are essential components of the following / enclosed sublease contract.

### 1.2 Organizer:

Schaffhof Connects GmbH & Co. KG, Schaffhof / Schwalbacher Strasse 1, 61476 Kronberg i. Ts, registered in the commercial register of the Königstein i. Ts. Under HRA2919. Personally liable partner: Schaffhof Connects Verwaltungsgesellschaft mbH, Schaffhof / Schwalbacher Straße 1, 61476 Kronberg i. Ts, registered in the commercial register of the Königstein i. Ts. under HRB2919

1.3 Event and exhibition location: Festhalle Frankfurt Panorama (level 1.0), Patio (level Via Mobile), Foyer Forum (level 0), Festhalle (level 0), Südfoyer (level 0), Steinerner Saal (level 0)  
The organizer uses the event space based on a rental agreement with the local trade fair company. As a sub-tenant, the exhibitor is also obliged to comply with the provisions of the main rental agreement, which can be viewed by the organizer after prior registration.

### 1.4 Event date:

Start: December 13th, 2023-5 pm End: December 17th, 2023

## 2. Registration:

2.1. Registration for participation in the event as an exhibitor requires the use of the organizer's registration form. The exhibitor must fill out the registration form completely and sign it in a legally binding manner.

2.2. By submitting the registration, these exhibition conditions of Schaffhof Connects GmbH & Co. KG are recognized, conditions or reservations of the exhibitor are not considered.

2.3. We particularly point out that only products and services that have been registered in advance and approved by the exhibition management may be exhibited and sold. The exhibitor is not entitled to rent or transfer the stand assigned to him to third parties without the approval of the organizer.

### 2.4 Registration deadline:

20/10/2023: Exhibitors from 2022 with prior claim a space  
01/11/2023: New interested parties and former exhibitors.

The exhibitors will be observed after the chronological receipt of the registration. The organizer has the right, in order to offer the visitors a variety of products, to reject exhibitors of the same or similar items.

## 3. Conclusion of contract:

3.1. The exhibitor will receive a written confirmation after a successful approval of his application. The organizer decides on the admission of the exhibitor to the event at its own discretion. The organizer is not obliged to give reasons for rejections from exhibitors. An exhibitor cannot rely on participation in a previous event.

3.2 Upon receipt of the written confirmation, the offer to conclude the sublease contract is accepted for the duration of the event and the contract is effectively closed.

## 4. Opening times:

4.1. Every day from the start of the first class until the end of the last break on each day of the event. The event times can be found in the short schedule.

4.2. To maintain the overall picture, all exhibitors commit to accept the opening hours and to keep their trade stands open and operate within the opening hours.

## 5. Construction:

5.1. Depending on the area, Tuesday, 12/12/2023 from 7 a.m. to 9 p.m. and / or Wednesday, 13/12/2023 from 7 a.m. to 5 p.m. The exhibitor will be informed of the respective set-up time in the written confirmation of receipt of the exhibition space.

5.2. Up to the time of construction, the organizer is entitled to allocate a different stand area to the exhibitor than that stated in the written confirmation if this is necessary for planning reasons, the overall design of the event, the available capacity or the structural conditions. A right of withdrawal or a claim for compensation from the exhibitor or other claims of the exhibitor are excluded in this case, unless the stand space offered falls short of or exceeds the agreed stand space by 15%. In this case, the exhibitor can withdraw from the organizer in writing. Otherwise the stand rental must be adjusted accordingly.

## 6. Dismantling:

Sunday, December 17, 2023, from approx. 7.00 p.m. to 0 p.m.  
Monday, December 18, 2023, from 8 a.m. to 12 p.m.  
A prior dismantling or the complete or partial evacuation of a stand is not permitted. Dismantling is recommended on Sunday out of safety reasons.

## 7. Withdrawal and non-participation:

7.1. After admission (order confirmation and / or presentation of the invoice), the exhibitor can withdraw up to four weeks before the event free of charge.

7.2. If an exhibitor does not take part in the exhibition for reasons for which he is responsible and without giving due notice, and if the corresponding exhibition space is allocated to maintain the overall visual image, this does not release the exhibitor from his payment obligation. If an exhibitor does not participate, the full fee

must be paid.

7.3. The organizer is entitled to withdraw from the contract with the exhibitor and to demand compensation from the exhibitor if the exhibitor, despite a corresponding request from the organizer and fruitless expiry of one set by the organizer reasonable time • Issues unreported or unauthorized goods or services or used goods, unless the latter are used for demonstration purposes;

• is in arrears with payments to the organizer;  
• sublet stand space or let third parties use it without the consent of the organizer;  
• Stand construction and dismantling outside of 5 and 6 deadlines; or  
• do not comply with the requirements of the stand size in accordance with. No. 8 holds.

7.4 If the organizer withdraws from the contract, the organizer has a claim against the exhibitor for compensation in the amount of the total contractually agreed stand rent and for payment of the ordered special services. The organizer reserves the right to assert further claims for damages.

7.5 Instead of withdrawing and asserting compensation, the organizer can choose the exhibitor to remove these goods in the event of unregistered, unauthorized or used goods, or in the event of subletting or relinquishing the stand to a third party without the organizer's consent of the stand by third parties, in the event of non-compliance with specifications for the design and equipment of the stand to adapt the design or removal of the stand

## 8. Stand size:

8.1. The minimum size is 6m<sup>2</sup>. Only full meters (in width and depth) are rented for an exhibition stand.

8.2. The rented partition walls of the organizer with a height of 2.5m may not be built over with a stand construction system.

## 9. Trailer:

It is not possible to place trailers in the exhibition.

10. Electricity and water connections: A sufficient amount of cables, stand lighting, extensions, hoses, connecting and connecting parts must be brought by the exhibitor.

## 11. Stand construction system:

A stand construction system including carpet is automatically ordered upon registration and is mandatory for every stand in the exhibition. Own stands may only be used with the written approval of the organizer. The height of the exhibition walls is 2.5m. With the stand construction system provided by the organizer, the exhibitor is liable for damage caused in the event of damage.

## 12. Aperture:

Each stand will get an aperture.

## 13. Traffic routes:

The traffic routes must be observed in the exhibition. Superstructures are not permitted and can lead to exclusion.

## 14. Parking spaces:

14.1. A parking space for the parking of cars and trucks (trailers) is available for the exhibitors.

14.2. Caravan parking spaces and any electricity and water requirements must be ordered separately from the organizer up to two weeks before the start of the event

## 15. Disposal:

The residual materials, packaging materials, kitchen and production waste generated during the event are to be disposed of by each individual exhibitor themselves after the event closes.

## 16. Special services:

Special services will be billed separately.

## 17. Terms of payment, right to exclusion:

17.1. All prices are net prices. They are subject to VAT.  
17.2. After invoicing, the entire invoice amount must be paid by bank transfer by December 1st, 2022. With full payment by November 17th. In 2023, a 3% discount will be granted on the net amount of the stand space. The exhibitor is in default without a reminder with the expiry of 01.12.2023. In this case, the exhibitor must pay default interest in the amount of the statutory default interest rate in addition to the payments owed.  
17.3 If an exhibitor is in arrears with his payment, the organizer is entitled to prohibit the construction and to exclude the exhibitor from the event.

## 18. Guarding:

General guarding of the site is arranged by the organizer. **The exhibitors are responsible for guarding the stands.**

## 19. Liability of the organizer / insurances:

19.1. The organizer assumes no duty of care for trade fair goods, stand facilities or other on the event brought items and excludes any liability for damage and loss.

19.2. The organizer is liable in the event of intent or gross negligence. In the event of a negligent breach of duty by the organizer or his vicarious agents, liability is limited to the foreseeable damage typical of the contract. In the case of slightly negligent breach of insignificant contractual obligations, liability is completely void towards entrepreneurs.

19.3. The above limitations of liability do not apply to physical or health damage attributable to the organizer or in the event of loss of life.

19.4 It is recommended that the exhibitor take out **their own insurance and business liability insurance** for the exhibition goods.

## 20. Commercial legal protection:

20.1. The exhibitor must refrain from violating or impairing industrial property rights.

20.2. The organizer reserves the right to exclude the exhibitor from the event and future events in the event of a proven violation of property rights by an exhibitor. In this case, the exhibitor must pay the full stand rental and other fees for the event to the organizer.

The assertion of further claims by the organizer against the exhibitor remains unaffected.

20.3 The assertion of claims by an exhibitor against the organizer due to a violation of the exhibitor's industrial property rights by third parties is excluded.

## 21. Exhibitor passes:

21.1. Exhibitor passes are personal.

21.2. Two exhibitor passes are issued free of charge per 8m<sup>2</sup> of stand space. Additional passes can be ordered separately from the organizer.

21.3. The maximum number of pieces is limited to eight passes per exhibitor.

## 22. Final provisions:

22.1. Verbal side agreements to the exhibition contract / sublease contract between the organizer and the exhibitor do not apply. Amendments and supplements to the contract must be in writing. This also applies to a change, addition or cancellation of this written form clause itself.

22.2. For the exhibition contract and these exhibition conditions, only the law of Federal Republic of Germany application. The applicability of the UN sales law is excluded.

22.3. The place of jurisdiction for disputes arising from and in connection with the exhibition contract / sublease contract and the general exhibition conditions is Königstein i. Ts

22.4. Should individual provisions of the exhibition contract / sublease contract be or become ineffective in whole or in part, this shall not affect the validity of the remaining provisions of the exhibition contract / sublease contract.  
Organizers and exhibitors undertake to replace the wholly or partially ineffective regulation with an effective regulation, the economic success of which comes as close as possible to the ineffective regulation.
